



Facebook Likes Contest OFFICIAL RULES

Promotion Sponsor:

Southwest Washington Chapter of Credit Unions

1. Eligibility: The Southwest Washington Chapter of Credit Unions (SWCCU) Facebook Likes Contest (Promotion) is open and offered to legal residents and employees, directors and volunteers of Credit Unions located in Washington, Oregon and Idaho, age 18 or older as of October 1, 2019. Members of the SWCCU Board and employees of Northwest Credit Union Association (NWCUA) are not eligible. By entering, you agree to these Official Rules and the decisions of Sponsor, which are final and binding in all respects. Void where prohibited.

2. Promotional Period: Promotion begins October 11, 2019 at 9:00 a.m. Pacific Time ("PT") and ends when the number of "Likes" for the SWCCU Facebook site reaches 50.

3. Prize/Odds: One (1) person (Winner) will be selected randomly from those who have "liked" "Commented" and "Shared" the SWCCU Facebook site to receive a \$50 Visa Gift Card (Prize). The winner taking possession of the Prize is solely responsible for taxes. The Prize may not be substituted, transferred or exchanged. There are no other prizes. Odds of winning are 1 in 50. If a winner cannot accept the Prize as stated, Prize will be forfeited and awarded to an alternate winner.

4. Entry: "Like," "Comment" and "Share" the SWCCU Facebook site to be entered in the Promotion. One entry per person. No purchase necessary.

Entrants may not enter with multiple identities. Any entrant who attempts to participate with multiple identities to obtain more than the maximum number of entries may be disqualified.

5. Drawing: One (1) random drawing for the \$50 Prize will take place once the SWCCU Facebook site reaches 50 "Likes." One (1) winner will be selected for a \$50 Visa Gift Card Prize. Winner must conform to and agree to all General Conditions listed in Section 6. If not, an alternate Winner will be drawn until an eligible Winner accepts the General Conditions. Winner will be notified by

phone, email or Facebook Message the next business day after drawing. Winner need not be present for the drawing.

6. General Conditions: Winner must be able to verify he/she was 18 years of age as of October 1, 2019. Winner may be asked to complete, execute and return an IRS Form W9, a Liability Release, and where lawful, a Publicity Release prior to taking possession of the Prize. Failure to sign documents, or if Prize notification is returned as non-deliverable, or if winner is found to be ineligible or not in compliance with these official rules, then disqualification will result and an alternate winner will be selected. Arbitration/Choice of Law: Except where prohibited by law, entrants agree that: (1) any and all disputes, claims, and causes of action arising out of or connected with this Promotion, or any prize awarded, or the determination of the winner shall be resolved individually, without resort to any form of class action, and exclusively by arbitration pursuant to the Rules of the American Arbitration Association then effective; and (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
